**EXTRACT PARTICIPATION RULES** Here enclosed some simple information that you will find in the details in the event show conditions. You can register your horse online from [www.showmanager.eu](http://www.showmanager.eu). Paper forms registration must be sent by **October 23, 2019** to: [itrha@itrha.com](mailto:itrha@itrha.com) with a request for confirmation or fax 0521-812423 (reservations without the signature of the applicant will not be accepted) All horses participating in the 3 and 4 years old Futurity must be provided with the NRHA Competition license and the NRHA membership card valid for 2019. If you still miss these documents you are kindly asked to request them in good time from the NRHA. You will find all the information on our website. As stated in the NRHA regulations it will not be possible to issue any new competition license during the show.

A veterinarian will also check the passports of the horses. No horse without a renewed passport can participate in the event. **Only the sons of stallions enrolled in the IRHBA Breeding Program can participate in the 3 years old Futurity in the four proposed levels. (1-2-3-4)**

**The Non Pro Futurity will take place in 1 Go and the "Consolation" category is scheduled for all four levels: The horse/rider combination that has achieved a score that will not allow them to directly access the final will be able to enroll in the consolation (for the number of riders who can enter in the Consolation and the number of those who can, depending on the score achieved, enter directly to the final, please refer to the rules FUTURITY 3 years old Non Pro).**

Horses enrolled in the Futurity 3/4 years old Lev. 1-2-3-4 (Non Pro and Open) that have not settled, as per regulation, their registration within the deadline, will be able to pay the amount directly at the competition with the addition of the amount for late payment as defined (see registration form).

For the reservation of the stalls, please use the attached form or register online from [www.showmanager.eu](http://www.showmanager.eu). By registering online you will save the cost of the office charge. Please note that for those who do not indicate on this form the date of arrival, the organization may not guarantee early check-in. **The arrival of the horses can only take place starting from 08.00 am on Wednesday 20 November 2019.**

**HEALTH CERTIFICATES:** Infectious anemia (Coggins test): all Equidae must be handled in accordance with the rules in force in the Regions of origin (D.M. SAN 2.2.2016). In particular: equidae coming from high-risk regions (Abruzzo, Calabria, Campania, Lazio, Molise, Puglia, Sardinia, Sicily) will only be able to access the event if they have a coggins test valid for one year; Equidae coming from the other Regions, qualified at low risk, must be in possession of a Coggins test carried out during the previous three years. (\* subject to changes by the competent authorities).

**Foreign horses do not need a Coggin Test.**

Young horses under the age of three must still have a Coggins test performed during their life except for foals aged less than six months, for which no test is required. The test result, for all subjects, must be reported on the individual identification documents of the subject, with the stamp and signature of the local health authority.

Equine Influenza: All Horses must be in possession of Influenza vaccination with a cycle of at least 30 days

Horses will be able to access the facilities of the Cremona Fair as follows: entry from the HORSES ENTRANCE.

There will be available a PREFERENTIAL ACCESS reserved for those who will provide beforehand the data relating to horses and transport by filling out the form on-line at <http://www.futurity.it>.

The horses participating in the Final of the Italian Championship (we remind you that only qualified riders can participate in this competition) and NRHA ancillary classes will only be able to access the facility from Sunday – November 23 . In case of early arrival the cost of the participation fee will be equivalent to that of the Futurity (€ 300.00).

For horses participating in the Futurity classes the facility will be available from **Wednesday November 20** and no further payment will be asked. It will not be possible to access the facility before this date. For NRHA ancillary classes it will not be possible to make schooling classes, the participants will have to follow only the designed pattern and the duration of the same can not exceed 4.5 minutes. For the Futurity finalists (3-4 years old) a 5minute paid-warmup is scheduled and will take place in the Arena B). All horses are required to wear their back number and the riders the bracelet of the event in all places and for the total duration of the event. The horses participating in all the ancillary events, until the end of the go rounds, will be able to use the main arena only for three hours after the qualifying go rounds is finished. At other times only the horses of 3 and 4 years enrolled in the Futurity will have access to the main arena with a back number. With the starting orders, a timetable for using the main arena and the warm-up arenas will be announced.

For the best use of the warm up arena in favor of the participating riders, each rider in the warm-up arenas can not be assisted by more than two helpers. During the finals a special pass will be handed out for access to it. During the night and daytime hours there will be a check made by the official Steward. The Steward in charge will have the right to stop or eventually suspend the performance of the riders. The farrier and veterinary will be assured, according to the NRHA regulation, from 30 minutes before the beginning of each day of competition until the end of the same. The presence of the ambulance and first aid service is guaranteed only when the show is running. Outside the scheduled hours the organizing committee is not responsible for what could happen to riders / spectators. Useful first aid numbers can be consulted in the appropriate board. For each contribution of part. a free ticket will be delivered (two for the 3 years old Futurity subscribers) to access the Futurity finals. Anyone wishing to buy tickets in advance can access the special section of the site <http://www.futurity.it/it/biglietti.html>

For a better organization please send online or fill out the stall reservation form in all its parts. It is necessary to communicate the prescriptions for all participating horses (For Futurity classes, the cost of registration for those who have already paid the amount due will be sent with the invoice). During the competition you can make all the necessary changes or add categories. All bookings sent without the requirements will be rejected.

ANY FURTHER REGISTRATIONS IN OFFICE WILL NOT BE ACCEPTED ONLY IF THE NUMBER OF MEMBERS EXCEED THE TIMES FOR A NORMAL DEVELOPMENT OF THE CATEGORIES OF THE DAY. You can confirm them the day before the competition.

The draw of all the finals (Futurity 3 and 4 years old) will be formulated in a seeded format (the highest score in the go round will be the last to enter in the final and each rider with more than one qualified horse , as per NRHA regulation, will have a range of at least 8 horses if the number of qualified horses will allow to apply this rule.

It is absolutely mandatory to keep dogs on a leash inside the Cremona Fiere facilities, providing the owners to remove and collect any dejections produced by them. The staff of the organization reserves the right to conduct, in special enclosures, all the dogs found without a leash: to the owners, upon redelivery, a fine of € 25.00 to a maximum of € 100.00 will be requested.

Each participant Italian rider must be in possession of a FISE license valid for 2019 or a guest license for foreign riders which must be covered by personal insurance.

For payments of the amount due, you can pay by bank transfer (Banca Popolare Emilia Romagna - IRHA **IT69K0538765700000001254566 BIC: BPMOIT22XXX**) or credit card from the IRHA website upon receipt of our confirmation receipt. Bank checks will not be accepted during the show. If you have not yet submitted the IRHBA free certificate, please send together with your reservation. The amount of the IRHBA discount will be discounted in your proforma invoice that will be sent to you to confirm your registration. The payment of the prizes will not be made during the competition: therefore, please indicate your Iban and swift on each registration form in order to be able to provide the balance of the prize eventually obtained on time. (the payment of the prizes will take place **only after** the results of the doping controls provided for by the regulation, taxes will be applied following the Italian regulation).

The organization is not responsible for theft of personal items of the participants, even inside the vehicles parked in the internal areas provided. The internal parking of cars, caravans or trucks (pitches with water and electric connections) and all means of transport of horses, will be regulated by special rates.
