Update to 2020 NRHA Euro Futurity – NRHA IRHA Futurity Terms and Conditions as of April 19, 2021:

The Italian Reining Horse Association is fully committed to holding the 2020 NRHA EUROFuturity & Italian Futurity at **Cremona Fair 15- 22 May 2021**

Under no circumstances the event will be cancelled unless required by state or local government.

The safety and welfare of our members and equine athletes remains paramount, and every effort and precautionary measure has been taken to ensure the event meets local guidelines and Government recommendations. **The horse stalls and all spaces used for the Futurity will be sanitized by a specialized company external to the organization before the event, which will issue a regular certification, however all the protocols already indicated in the document "FUTURITY VETERINARY PREVENTION EHV will be strictly followed.**

You can confirm your entries up to May 2, if you cancel after this date we will ask you to pay just for the cost of the stall.

However, in the unlikely event that the *Euro Futurity – NRHA- IRHA Futurity* is closed due to orders issued by the City of Cremona and/or the Regione Lombardia or the State of Italy, IRHA is fully prepared with the following contingency plans.

The IRHA Executive Committee has proactively approved the following:

If IRHA is forced to cancel the Open or Non Pro Euro Futurities/IRHA-NRHA Futurity ***prior to the completion of the first go-round:***

- Every effort will be made to reschedule the event within in a timely manner. Entry fees will automatically be put toward the new event and eligibility will remain the same. The first go-round will be started over. Ancillary classes will be re-scheduled as well.

If IRHA is forced to cancel the NRHA/IRHA Open Futurity ***after the completion of the first go-round but before the completion of the second go-round:***

- The results of the first go-round will be accepted as the final results and recorded and paid out as such.

If IRHA is forced to cancel the Open Futurity ***after the completion of the second go-round but prior to the finals:***

- Composite scores from the first two go-rounds will determine the final results. Results will be recorded and paid out as such.

If IRHA is forced to cancel the EURO Futurity (Open and Non Pro) and Futurity IRHA Non Pro Futurity ***after the completion of the preliminary round but prior to the consolation round:***

- The results of the first go-round will be accepted as the final results and recorded and paid out as such.

If the NRHA is forced to cancel the EURO Futurity (Open and Non Pro) and Futurity IRHA Non Pro ***after the completion of the consolation round:***

- The top 15/20 horses depending on the numbers of entries (plus ties) from the L4, L3, L2 and L1 preliminary round and the top 2-3-4 horses (plus ties) from the consolation round will be accepted as the final results and recorded and paid out as such.
- **All classes will be paid as per the regulations for each individual class in the condition of participations**

If IRHA is forced to cancel ***any ancillary classes, but the Futurity classes do not need to be rescheduled:***

- Every effort will be made to reschedule these classes to be added to a future event
- Entries in any ancillary classes that are cancelled and are unable to be rescheduled will receive a full refund on their entry fees.
- **For the 3-years old Futurity** added money as already present in the current conditions of participation, if the registrations will drop by 20% compared to what is inserted in the budget (referring to the income of the previous years) the added money could vary from € 300,000 expected up to no less than € 180,000 and the cost of registrations will have a proportionally decrease
