EXTRACT PARTICIPATION RULES Here enclosed some simple information that you will find in the details in the event show conditions. You need to register your horse online from www.showmanager.eu by **October 09, 2022** to: itrha@itrha.com All horses participating in the 3 and 4 years old Futurity must be provided with the NRHA Competition license and the NRHA membership card valid for 2022. If you still miss these documents you are kindly asked to request them in good time from the NRHA. You will find all the information on our website.

A veterinarian will also check the passports of the horses . No horse without a valid passport can participate in the event.

IRHA-IRHBA – NRHA 3 yrs old Futurity: Only the sons of stallions enrolled in the IRHBA Breeding Program or foals enrolled separately can participate in the 3 years old Futurity in the four proposed levels. (1-2-3-4)

The Non Pro Futurity will take place in 1 Go and the "Consolation" category is scheduled for all four levels: The horse/rider combination that has achieved a score that will not allow them to directly access the final will be able to enroll in the consolation (for the number of riders who can enter in the Consolation and the number of those who can, depending on the score achieved, enter directly to the final, please refer to the rules FUTURITY 3 years old Non Pro).

If registrations drop by 20% compared to what has been included in the budget (referring to previous years' revenues), the added money could vary

NRHA IRHA 4 YEARS OLD: All 4-year-old horses will be able to participate in the mentioned categories which will take place in 1 go plus final for the proposed levels. There is no consolation for these classes.

Any horse owner enrolled in the 3-4 year Futurity will have an access code for free viewing of the event.

For the classes of the Italian Championship, free viewing will be guaranteed to all users.

"Pre-registered" participants must present themselves for veterinary controls indicating their receipt number: the veterinary staff of Local Health Authority AULSS 9 VERONA, if necessary, may request additional details. If, on the other hand, all documentation is compliant and in accordance with the law, the inspection coupon will be issued and vehicles will be allowed to access the exhibition centre. For horses participating in the Futurity classes the facility will be available from **Wednesday 09 th November 2022** and no further payment will be asked. It will not be possible to access the facility before this date. For NRHA ancillary classes it will not be possible to make schooling classes, the participants will have to follow only the designed pattern and the duration of the same can not exceed 4.5 minutes.

All horses are required to wear their back number and the riders the bracelet of the event in all places and for the total duration of the event. The horses of the Italian championships will be able to access the main arena at the times that will be defined during the show

At other times only the horses of 3 and 4 years enrolled in the Futurity will have access to the main arena with a back number.

With the starting orders, a timetable for using the main arena and the warm-up arenas will be announced.

For the best use of the warm up arena in favor of the participating riders, each rider in the warm-up arenas can not be assisted by more than two helpers. During the finals a special pass will be handed out for access to it. During the night and daytime hours there will be a check made by the official Steward. The Steward in charge will have the right to stop or eventually suspend the performance of the riders. The farrier and veterinary will be assured, according to the NRHA regulation, from 30 minutes before the beginning of each day of competition until the end of the same. The presence of the ambulance and first aid service is guaranteed only when the show is running. Outside the scheduled hours the organizing committee is not responsible for what could happen to riders / spectators. Useful first aid numbers can be consulted in the appropriate board.

It is MANDATORY to communicate the prescriptions for all participating horses. During the competition you can make all the necessary changes or add categories. All bookings sent without the requirements will be rejected.

ANY FURTHER REGISTRATIONS IN OFFICE WILL NOT BE ACCEPTED ONLY IF THE NUMBER OF MEMBERS EXCEED THE TIMES FOR A NORMAL DEVELOPMENT OF THE CATEGORIES OF THE DAY. You can confirm them the day before the competition.

The draw of all the finals (Futurity 3 and 4 years old) will be formulated in a seeded format (the highest score in the go round will be the last to enter in the final and each rider with more than one qualified horse, as per NRHA regulation, will have a range of at least 8 horses if the number of qualified horses will allow to apply this rule.

It is absolutely mandatory to keep dogs on a leash inside the Cremona Fiere facilities, providing the owners to remove and collect any dejections. The staff of the organization reserves the right to conduct, in special enclosures, all the dogs found without a leash: to the owners, upon redelivery, a fine of € 25.00 to a maximum of € 100.00 will be requested.

Each participant Italian rider must be in possession of a FISE license valid for 2022 or a guest license for foreign riders which must be covered by personal insurance.

For payments of the amount due, you can pay by bank transfer (Banca Popolare Emilia Romagna - IRHA **IT69K0538765700000001254566 BIC: BPMOIT22XXX**) or credit card from the IRHA website upon receipt of our confirmation receipt. Bank checks and cash will not be accepted during the show. If you have not yet submitted the IRHBA free certificate, please send together with your reservation. The amount of the IRHBA discount will be discounted in your proforma invoice that will be sent to you to confirm your registration. The payment of the prizes will not be made during the competition: therefore, please indicate your Iban and swift on each registration form in order to be able to provide the balance of the prize eventually obtained on time. (the payment of the prizes will take place **only after** the results of the doping controls provided for by the regulation, taxes will be applied following the Italian regulation).

The organization is not responsible for theft of personal items of the participants, even inside the vehicles parked in the internal areas provided. The internal parking of cars, caravans or trucks (pitches with water and electric connections) and all means of transport of horses, will be regulated by special rates.
