HEALTH STANDARDS 2022

Introduction

Health and hygiene monitoring and the prevention of contagious diseases, within the scope of Fieracavalli organised by Veronafiore S.p.A., are performed by the Veterinary Service of Local Health Authority AULSS "Scaligera" no. 9; exhibitors must scrupulously adhere to the dispositions that from time to time are issued by this Authority.

Veterinarians will be permanently at the disposition of Exhibitors in the exhibition centre itself in order to issue health certificates and provide any assistance services that may be required.

It is absolutely forbidden to hinder in any way the performance of such monitoring and everyone concerned is requested to provide maximum collaboration and assistance to Health Officials in the course of their work.

Horses operators and professionals will cooperate (Chapter 3, Section 1, Article 10 of EC Regulation 429/2016) with the Official Veterinarians on duty in the Exhibition Centre to report any case, including suspected disease, as per Articles 5 and 9 of EC Regulation 429/2016 and Article 1 of the Italian Veterinary Police Regulations n. 320 dated 8 February 1954 as amended.

Horses cannot be admitted to the exhibition centre unless they meet the health requirements listed below.

N.B.: Reservation is made as regards full compliance with any health standards and regulation updates that may be issued from today until FIERACAVALLI is held by the Ministry of Health or the Veneto Region in response to changes in animal farming conditions.

GENERAL INDICATIONS

All animals must be accompanied by the health certificates envisaged by current legislation for each breed.

Animals entering Italy must be accompanied by a Declaration of Origin (Form 4 filled out in compliance with the provisions of the Decree of the Ministry of Health dated 28 June 2016 as amended) appropriately validated or with certification of the favourable outcome of the health check and tests carried on livestock (where envisaged by current health standards).

Horses arriving from EU Member States must be accompanied by certificates compliant with the provisions of Regulation 403/2021/EC dated 24 March 2021.

The Veronafiore identification code to be indicated on Form 4 or international certificates is:

IT091VR77M

A copy of these certificate must be provided to the Official Veterinarians of Local Health Authority AULSS n. 9 Scaligera before arranging animals in the spaces assigned to them.

Any consignments of horses without the required certificates will not be allowed to enter the exhibition centre.

If the Veterinary Service ascertains or suspects contagious infectious diseases, Veronafiore S.p.A. herein declines any and every responsibility for the spread of such diseases to other horses; in any case, legal procedures in conformity with current health regulations and standards shall apply.

1. EQUIDAE (Horses - Donkeys - Mules - Hinnies)

Equidae arriving from Italian territory at the Verona Exhibition Centre must be accompanied by the ID document (Passport) certifying registration with the national equine registry in accordance with the provisions of the Ministerial Decree dated 30 September 2021 and the related implementation procedures/instructions.

All Equidae over the age of twelve months will be admitted to the exhibition centre provided they have undergone the checks provided for in the Decree 02 February 2016 National Plan for the Surveillance and Control of Equine Anaemia (OJ General Series No. 96 dated 26-4-2016), i.e. they must be for infectious equine anaemia in accordance with the period/validity indicated in the foregoing decree and the results must be annotated on the relative passports.

In accordance with the provisions of the Decree of the Ministry of Health dated 28 June 2016, the integrated Form 4 must be compiled by the sender (electronic Form 4 - ALSO VALID FOR RETURN).

Equidae from Member States of the European Union must:

- be correctly identified and accompanied by a Passport as per the EU Implementing Regulation (EU) 2021/963 dated 10/06/2021 defining the methods of application of regulations (EU) 2016/429, (EU)2016/1012 and (EU) 2019/6 of the European Parliament and the Council regarding the identification and registration of equine animals as well as defining identification document models for these animals
- accompanied by a certificate as referred to in Delegated Regulation 2020/688/EC supplementing Regulation (EU) 2016/429 of the European Parliament and the Council regarding animal health requirements for movement within the Union of terrestrial animals and hatching eggs (art. 22, art. 76 and annex VIII part 1, item 1); the health certificate form must comply with the provisions of Regulation 2021/403.

Equidae from other countries must transit through a Frontier Inspection Point (FIP) and be accompanied by a "Common Entrance Veterinary Document" (livestock CEVD) issued by the FIP.

TRANSPORT REGULATIONS

Livestock must be transported under the conditions established by Reg. 1/2005/EC as amended and hauliers must exhibit at the entrance to the Fair the certification of the eventual disinfection (Article 64 of Veterinary Police Regulations).

On entering the Exhibition Centre, all documentation (copy of Form 4, passports and transport authorization) must be presented to the Veterinary Service.

After unloading livestock, vehicles may not leave the Exhibition Centre until they have been washed and disinfected in the specific service area inside the Showgrounds.

Once again, this year ONLINE PRE-REGISTRATION will be MANDATORY:

"Pre-registered" participants must present themselves for veterinary controls indicating their receipt number: the veterinary staff of Local Health Authority AULSS 9 VERONA, if necessary, may request additional details.

If, on the other hand, all documentation is compliant and in accordance with the law, the inspection coupon will be issued and vehicles will be allowed to access the exhibition centre.
