In consideration of my participation in the **Euro Futurity 2025 event**, I expressly authorize the Italian Reining Horse Association and the Organizing Committee of the event to process my personal and sensitive data pursuant to and for the purposes of Legislative Decree 196/2003 and of the European regulation 679/2016, also expressly authorizing them to publish and / or record, in any form and / or on any media (for example, internet sites, social media, printed media, video streaming, etc.), of photographic material and videos made as part of the above event that may affect my person and my / my horse / I, renouncing from now on any protest in this regard.

I declare under my personal responsibility to have taken out insurance policy to cover any damage suffered by me and or / my horse as well as any damage, injury or personal injury caused by me and / or my horse / to third parties during the event. Any lack or insufficiency of the insurance policy will entail on my part, the loss of the right to formulate claims for damages against IRHA and the Organizing Committee. However, I undertake to address any claims for damages suffered by me and / or my horses during the event exclusively towards my insurance or third parties other than IRHA and the Organizing Committee, exempting from all responsibility the IRHA and the Organizing Committee and all its managers and representatives for any accident or injury suffered by me and or / my horse / I, as well as for any damage caused by me or my / my horse / third parties (injuries, personal injury and 'other') during the event, including the present as a waiver of the right of action against IRHA and the Organizing Committee, as well as any requests for indemnity, regression or guarantee against them for events that occurred during the event.

I have the authority and hereby do, by making this entry, to assume responsibility for and bind owner, rider and/or agent and all the persons included on the entries form to the terms and conditions of this Release and Waiver of Liability. I warrant that I am of legal age and that I have read and fully understand the foregoing terms.

I represent and warrant that I am the parent or legal guardian of the participant named above, that I am of legal age and that I have read and fully understand the foregoing release and agree for participant's heirs, successors and assigns, and for participant's legal representatives to be bound by the terms thereof.

EXTRACT PARTICIPATION RULES Here enclosed some simple information that you will find in the details in the event show conditions. You need to register your horse online from www.showmanager.eu by **April 22, 2025** All horses participating at the show must be provided with the NRHA Competition license and the NRHA membership card valid for **2025**. If you still miss these documents, you are kindly asked to request them in good time from the NRHA. You will find all the information on our website. A veterinarian will also check the passports of the horses. No horse without a valid passport can participate in the event. The boxes not cancelled by April 22nd will need to be paid at the cost of €150.00

NRHA EUROFUTURITY: Only the foals enrolled in the NRHA Nomination Program can participate in the 4 years old Futurity in the four proposed levels. (1-2-3-4)

The Futurity will take place in 1 Go and a Final for all proposed levels

EUROFUTURITY PAINT HORSE ASSOCIATION 4 yrs old

Restricted to 4 yrs old Paint horses.

It is mandatory to enrol the horses in the Euro Futurity standard classes. See attached conditions

NRHA ANCILLARY CLASSES

For NRHA ancillary classes it will not be possible to make schooling classes, the participants will have to follow only the designed pattern and the duration of the same cannot exceed 4.5 minutes.

For the reservation of the stalls, please register online from www.showmanager.eu.

The arrival of the horses can only take place starting on May Sunday 18, 2025 from 2,00 pm. NO POSSIBILITY TO ENTER BEFORE THIS DATE AND TIME. The main arena will be available after 8,00 pm

The live streaming for the EUROFUTURITY 4-year-old classes (go and finals) will be available for purchase. However, every horse owner registered for the EUROFUTURITY 4-year-old event will receive a complimentary access code for viewing the event.

will be available on the websites www.irha.it in the imminence of the event, subject to health prevention, however subject to variations and adjustments if requested and / or imposed by the authorities.

Any horse owner participating in Euro Futurity will have an access code for free viewing of the event.

For horses participating in the Futurity classes the facility will be available from **May 18, 2025** and the arena will be available after **8,00 pm**. It will not be possible to access the facility before this date.

All horses are required to wear their back number and the riders the bracelet of the event in all places and for the total duration of the event.

With the starting orders, a timetable for using the main arena and the warm-up arenas will be announced.

For the best use of the warmup arena, in favour of the participating riders, each rider in the warm-up arenas cannot be assisted by more than two helpers. During the finals a special pass will be handed out for access to it. During the night and daytime hours there will be a check made by the official Steward.

The Steward in charge will have the right to stop or eventually suspend the performance of the riders. The farrier and veterinary will be assured, according to the NRHA regulation, from 30 minutes before the beginning of each day of competition until the end of the same. The presence of the ambulance and first aid service is guaranteed only when the show is running. Outside the scheduled hours the organizing committee is not responsible for what could happen to riders / spectators. Useful first aid numbers can be consulted in the appropriate board.

It is necessary to **communicate the entries for all horses participating in the EUROFUTURITY Categories**. These entries are not binding: during the competition, you may make any necessary changes and add or remove levels. The pre-entries for **the Ancillary classes must be submitted by the registration deadline and must be fully paid**, even if canceled before the competition. All bookings sent without the requirements will be rejected.

Riders may be entered into both the open and non pro Futurity division, but we suggest entering at the time of the entry deadline to assist with scheduling. Riders competing in the Non Pro Futurity who DO NOT MAKE THE FINALS will have 30 minutes after the conclusion of the last Non Pro horse's run to enter the Open division and they will be placed at the beginning of the Open second section (-1). All other entries after the entry deadline will be considered according to the timetable. Should the number of entries (prior to the conclusion of the Non Pro) exceed 120, no entries (outside of Non Pro entries who did not make the Non Pro finals) will be allowed to enter the Open.

ANY FURTHER REGISTRATIONS IN OFFICE WILL NOT BE ACCEPTED ONLY IF THE NUMBER OF MEMBERS EXCEED THE TIMES FOR A NORMAL DEVELOPMENT OF THE CATEGORIES OF THE DAY. You can confirm them the day before the competition.

Draws for the final sections will be executed by a random physical draw at a draw party posted on the schedule.

A free pass for the finals will be provided for each booked box

It is absolutely mandatory to keep dogs on a leash inside the Cremona Fiera facilities, providing the owners to remove and collect any dejections. The staff of the organization reserves the right to conduct, in special enclosures, all the dogs found without a leash: to the owners, upon redelivery, a fine of € 50.00 to a maximum of € 100.00 will be requested.

Each participant Italian rider must be in possession of a FISE license valid for 2025 or a guest license for foreign riders which must be covered by personal insurance.

For payments of the amount due, you can pay by bank transfer

Bank checks will not be accepted. The payment of the prizes will not be made during the competition: therefore, please indicate your Iban and swift on each registration form in order to be able to provide the balance of the prize eventually obtained on time. (the payment of the prizes will take place only after the results of the doping controls provided for by the regulation, taxes will be applied following the Italian regulation - 20%)

The organization is not responsible for theft of personal items of the participants, even inside the vehicles parked in the internal areas provided.

The internal parking of cars, caravans or trucks (pitches with water and electric connections) and all means of transport of horses, will be regulated by the following rates:
