



NEW BREEDERS PROGRAM DERBY

The new program is open to young horses and works alongside BIP as an incentive for reining horse breeders. The goal is to collect resources that will be destined, as a contribution, to the purse of the actually IRHA DERBY that in 2023 will be IRHA/IRHBA open to 4-, 5-, 6-, 7-, and -8-year-old horses, thus guaranteeing a higher purse for breeders and potential acquirers.

The program, in keeping Animal Welfare in mind, provides an opportunity to compete in an event with an important purse which is not destined exclusively to 3 year olds, but to horses aged 4 to 8 thus allowing them to mature and grow both physically and on an athletic level. It is also destined to give an opportunity to those who do not have their horses ready for the 3-year-old events to show in other important events. This new program, added on to the 3-year-old Futurity Breeder Program (IRHBA stallions + foals), provides the opportunity of having five Breeder Derbies with important purses.

Following a study regarding the numbers of horses entered in the Futurity and the Derby, it was noted that even though the Futurity purse is very interesting, over the years the numbers have remained relatively stable while there has been a significant increase at the Derby. It was therefore thought that this event should be given more

THE PROJECT:

1. Starting year: 2022

The first enrolment is for foals born in 2022 and a regularization for those born in 2015 through 2021.

2. Enrollment fees:

- **€ 200,00** for foals born in 2022-2021-2020 by stallions enrolled in BIP-IRHBA.
- Deadline: 30/09/2023.
- Regularization for stallions enrolled in IRHBA. Foals born before 31/12/2019 will need to pay before 28/02/2023. Table of foal enrollment fees according to year born:

Foals by stallions not enrolled IRHBA will need to pay as per above table according to the year of birth with an additional € 300,00 (does not apply to the foals already enrolled).

The Derby will be open to all horses.

Horses that have never been entered in the program may enter by paying double the amount according to year of birth.

For foals born in 2022-2021-2020-, and 2019 that would like to regularize their position in order to compete in the Futurity, please refer to the Entry Form with entry fees and deadlines which remains the same.

3. Added Money

Thanks to the new program and to the collaboration between IRHA and the Organizing Committee (LGV), the Derby added money will increase considerably starting in 2023 and will be close to triple in only two years thus reaching 320.000 euro in 2025.

IRHA-IRHBA-LGV guarantee the following minimum added money in the next three editions of the Derby.

The goal, starting 2026 when the program will effectively kick in, is to progressively increase the added.

The program, thanks to collaboration with IRHA and LGV, will guarantee an important added for the IRHA-IRHBA-NRHA Derby in 2023-2024-2025 without affecting the BIP destined to the 3-year-old IRHA-IRHBA Futurity which will offer—as in past years—a contribution to the added money between 150.000 and 200.000 euro.



ENTRY FORM FOR FOALS ELIGIBLE FOR THE DERBY

In order for foals to compete in the IRHA/IRHA Derby starting 2023, you must be an IRHBA member for the current year and foals must be by stallions enrolled in the BIP IRHBA.
