**Dear All,**

In consideration of the number and level of reining events organized by the affiliated associations in our country and throughout Europe, as well as the upcoming expiration of almost all the NRHA judges' licenses in Italy (since the validity of the NRHA card is only two years), the IRHA will organize an NRHA FISE judges' course and a Steward course from February 20 to 23, 2025, in Bologna.

This year, the course will be divided into three sections:

- **Steward Seminar: Thursday**, February 20 (from 08:30)
- **Judge Seminar: Thursday**, February 20 (from 08:30) **and Friday**, February 21 (full day)
- **Judge School: Friday**, February 21 (starting at 08:30) – **Saturday**, February 22 (full day) – **Sunday**, February 23 (ending by 16:00)

Based on the scores obtained during the **seminar** exam, candidates may be considered **NOT ELIGIBLE** or **ELIGIBLE** to attend the next NRHA School without receiving a Judge title.

The School (only for those who need to renew their NRHA judge status and for those who have passed the NRHA Seminar exam in a previous course) will take place on the above-mentioned dates and will include evaluation tests during the course and a final exam.

At the end of the School session and the related exams, candidates deemed eligible may obtain or maintain their NRHA "worldwide" judge title.

This year, there will also be an option for those who currently do not hold Judge status to attend the course as auditors, without taking the final exam. Participation as an auditor **WILL NOT** grant the Judge status. The auditor option is designed to offer an opportunity to improve knowledge of the Reining discipline for those who do not intend to obtain the Judge status. Auditors can attend the seminar on February **20-21**, and there is no age requirement of 25 for them.

To participate in the course, candidates must meet the following requirements:

1. Be at least 25 years old as of the start of the course, according to NRHA rules.
2. Be an NRHA member for at least the last two calendar years (i.e., since January 2023). This requirement is only necessary to become an official NRHA judge and to have participation in the seminar recognized.
3. The NRHA card and the IRHA card for the year 2025 can be paid for on-site.
4. Candidates for the Seminar and the School are encouraged to bring a personal laptop.

**PLEASE NOTE THAT ALL INTERESTED PARTIES CAN PARTICIPATE IN THE COURSE, EVEN IF THEY DO NOT HOLD AN NRHA MEMBERSHIP FOR THE LAST TWO YEARS, BUT THE PARTICIPATION IN THE SEMINAR CANNOT BE OFFICIALLY RECOGNIZED.**
