METHOD OF CONDUCT OF THE EVENT



PREMISES

After a rather long period of forced closure, event planning activities can finally resume. The recent c.d. regulation “Dpcm agosto”, in fact, allows the organization of fairs and events, as well as the organization of sport events.

Nevertheless, the strong and justified level of attention to the containment measures of the pandemic spread, implies that our organization make operative choices, clearly prioritizing the protection of the health of our customers, suppliers and collaborators.

For these reasons we decided to resume our business, but substantially modifying the event project (known and appreciated in its 32 previous editions), trying to combine the hoped-for reopening with organization methods that allow a safe event management.

Undoubtedly, the nature of the new event will be far from satisfying the expectations of our customers/usual visitors, but it will allow the resumption of national events for many disciplines, after more than a six-months waiting period where, among other things, it will be possible to visit commercial booths.

In addition to a specific sanitation of the environment host to the event, we have developed a health protocol according to the Ministerial, Federal and Association of Italian Fairs guidelines, which we believe is adequate to guarantee the safety standard that today represents a mandatory premise of our offer.



SCHEDULE OF THE EVENT and ACCESS AUTHORIZATION

In order to minimize the possibility of crowding of the structures, we felt it was necessary to split the event schedule over two back-to-back weekends.

In detail, Reining competition will take place on September 8 -12 while on September 17 - 20 the facility will host Cutting, Team Penning, Ranch Sorting, Barrel Racing and Pole Bending competitions.

In both cases, during both weekends, competition will be “BEHIND CLOSED DOORS”. Show arenas and nearby areas, stalls and any other technical areas used by the riders and / or collaborators, will therefore be **TOTALLY FORBIDDEN** to free access by third parties in general.

Vice-versa, only the following people will be able to access these areas (and will be equipped with devices to wear for immediate identification):

- competitors;
- trainers/instructors (mandatory in the case of a youth contestant);
- Grooms (please try to organize to have one groom for more horses);
- Horse owners (only if previously requested and if the owner’s name coincides with that of the horse's passport);
- Van drivers during the time required for unloading and loading operations;
- Both parents, or one person delegated by the parents, in the case of a youth contestant;
- Any additional persons requested by para athletes for particular personal needs;
- The following representatives of the National Sports Federations which approved the single events: Federal President; Federal Councilors; President of the Regional Committee / Representatives and Regional Councilors; General Secretaries and Sport Directors of the same federations;
- Any figure specifically delegated by the Federations;
- Any sponsor representatives invited by the Organizing Committee for the time necessary to carry out specific activities (for example attending the awards ceremony of the titled classes);
- Staff and / collaborators indicated by the Organizing Committee in charge of the organization of the event, as well as the technical figures required by federal rules;
- Veterinarians and / or assistants or farriers, if requested by the competitor, strictly for the necessary time of the visit, treatment or therapy of the horse;



- Any medical or paramedical staff, if requested by the competitor, strictly during the time necessary for the therapy to be performed.

All those who, within the strict scope of the previous list, want to access the exhibition facilities will still have the obligation to register in a specific section of the website www.salonedelcavallo.com in the 24 hours prior to accessing the fair.

At the time of this registration and for the sole purpose of personal traceability and health prevention, the following information / certificates will be required, among others:

- an individual declaration about the absence of symptoms attributable to the epidemic in progress in the previous 14 days;
- e-mail address;
- phone number;
- date and time of first access to the facility;
- declaration of the obligation to submit (during the whole period of stay at the facility) the daily temperature measurement and / or further health investigations that the personnel in charge of the controls deem appropriate.
- declaration of acknowledgment of the "health rescue plan and Covid-19 prevention measures";
- declaration of acknowledgment of the horse riding events protocol adopted by the Italian Equestrian Sports Federation (FISE);
- declaration of acknowledgment of health and individual prevention obligations;
- declaration of acknowledgment of the disciplinary code of conduct within the sporting event
- Personal data processing communication form.

At the fair entrance, staff will measure each individual's body temperature and will check the possession of individual protective devices (masks). This operation will be repeated at each access to the fair even if repeated several times during the day by the same person.

Measurement of body temperature must be taken daily also for all those people who sleep inside the exhibition center and who don't access from the outside. Health care service staff will be present with a fixed location inside the fairground where each guest must go to at set times which will be communicated at the fair.



Inside the facility (in the covered areas) everybody must wear personal protective equipment (mask), with the exception of those who, riding their horses, are training and / or competing in the specific and open arenas.

Behavior against to the procedures briefly described here (and deeply detailed in the attached emergency plan) will not be tolerated in any way, and if necessary, the assigned personnel is authorized to recall the imposed rules.

Any repeated transgressions or behaviors that could endanger the health of those present may result in a removal from the facilities, without any refund of the costs incurred by the offender and without prejudice to the health police activity by the competent authorities.

At the fair entrance, a communication will be delivered (in paper and / or digital form) regarding the behavior to be maintained within the show facility

The usual catering services (restaurant, self service, bar, etc.) will be activated during the events, according with the national implementation protocols. In particular, methods of access to the self service can be provided by booking specific times of access in order to ensure personal distancing between subjects not belonging to the same family group.

IMPORTANT NOTES

- Shower services for men and women will not be available.
- It is not permitted to bring dogs or pets in the covered areas (they may enter the fair if access is made by the camper or caravan, and they are kept exclusively in the parking areas).
- It is not permitted to circulate with wheeled vehicles (both motorized and manual traction) within the exhibition center, with the specific exception of wheelchairs or any other means of transport used by disabled people. As an inclusive but not exhaustive example, it is not possible to use any kind of scooters, overboard, bicycles, etc.



FAIR EXHIBITION

In separate areas from those dedicated to the horse shows, an exhibition fair dedicated to sector companies will be set up, with the usual presence of producers, equipment distributors and horse-back riding supplies, clothing and accessories. Also, there will be breeding, training centers and generically sector service booths.

Public access to the dedicated exhibition areas will be regulated as foreseen and described above for the riders.

There is no entry fee. Access will be free and will only be possible upon registration the day before the access. Failure by the user to activate the registration procedure (for any reason whatsoever) will result in a ban on the event entrance.

Horse competitions will be visible only by live streaming (free and / or paid) at www.salonedelcavallo.com.

No dance events will be hosted as previously foreseen in the schedule of the event.



ITALIAN TERRITORY ENTRY RULES *

As of 11 August 2020, the travel restrictions and rules regarding arrivals in Italy are divided into 4 segments:

- The first includes citizens from the Schengen Area (EU, plus Switzerland, Norway and Iceland), except Bulgaria and Romania, for which free movement is in force;
- arrivals from non-EU states, plus Bulgaria and Romania, is allowed for work or health reasons with the obligation of fiduciary quarantine.
- For 12 non-EU countries, entry is allowed, these are: Morocco, Algeria, Tunisia, Georgia, Canada, Uruguay, Thailand, South Korea, Japan, Australia, New Zealand and Rwanda.
- Furthermore, the following is a "black list" of 16 countries from which any kind of arrival is forbidden: Armenia, Bahrain, Bangladesh, Brazil, Bosnia Herzegovina, Chile, Kuwait, North Macedonia, Moldova, Oman, Panama, Peru, Dominican Republic, Serbia, Montenegro and Kosovo.
